2021 Adult Candidate Nomination Form

Each year, after holding an election for youth candidates that results in at least one youth Candidate being elected, the unit committee of a Troop, Crew of Ship may nominate registered unit adults (age 21 or over) as potential Candidates for consideration as Candidates by the Lodge Adult Selection Committee. **Unit adults must meet the same camping requirements as youth candidates** (see below), have not been inducted into the Order of the Arrow and **their primary registered position (i.e., paid) must be with the unit.** The number of adults who may be nominated is determined by the number of youth elected as candidates. If one youth is elected, one adult may be nominated. If two or more youth are elected then two adults may be nominated per three youth elected rounded up where the number of youth candidates is not a multiple of three. In addition to the one-third limit, the unit committee may nominate the currently-serving unit leader (but not assistant leaders), as long as he or she has been registered as unit leader for at least the previous 12 months. If the adult meets all eligibility requirements, the nominations will be reviewed by the Adult Selection Committee based upon the nominees ability and willingness to provide a positive example to youth and to benefit the OA program. Nominees approved by the Adult Selection Committee are submitted to the Scout Executive, serving as Supreme Chief of the Fire (or his or her designee) for approval. If approved as a Candidate, the Chapter Adviser will notify the nominee. Consult the Guide for Officers and Advisers for procedures for nominating district and council Scouters using this form.
